# Provisions for the use of certificates and certificate symbols

In these provisions the term Certified Centre+means a Centre that can present a valid certificate issued by the German Cancer Society (DKG). Depending on the type of centre, the full designation of the Centre will be used, for instance Breast Cancer Centre, Colorectal Cancer Centre, Oncology Centre.

#### General rules for using the certificate and the certificate symbol (logo)

The rules laid down in these provisions for using the certificate and the certificate symbol apply in full to the use of the designation % ertified Centre+, too.

- The owner of several clinics must ensure that there is a direct link to the certified location. The impression
  may not be given that other facilities of the owner are either directly or indirectly part of the Certified Centre.
- The cooperation partners listed in the master data sheet+may officially call themselves mertified cooperation partners. The master data sheet+is issued by OnkoZert and defines the certified scope of the Centre. Any cooperation partners of a Centre that are not listed in this master data sheet are not deemed to be part of the Certified Centre. Hence, they may not use the certificate or certificate symbol either directly or indirectly.
- If a cooperation partner is attached to a clinic which is not part of a Certified Centre, it may only use the designation % ertified Centre+in conjunction with the certified services provided by it to the Centre. Under no circumstances may the impression be given that other parts of the clinic themselves are or even the clinic itself is certified.
- The certificate symbol may only be used in conjunction with the name of the Certified Centre.
- Certificate symbols may only be used in the form provided. No changes to the design or colour are permitted.

# Provisions for the international use of certificates and certificate symbols

## Use of international logos and certificates

This section of the provisions is relevant and, therefore, only needs to be signed if there is a desire to use international certificates and certificate symbols.

## % UROPEAN CANCER CENTRES (ECC)+logo

The text module % UROPEAN CANCER CENTRES+is always in English (no translation into national languages, etc. is possible). The designation of the certification system in the logo (e.g. % Certified Breast Cancer Centre+) is normally available in German, English and French. Furthermore, it may be translated into the respective language of the country in which the Centre is located.

#### Centres with a location in Germany

- For centres in Germany the following applies: the certificate issued by DKG also entitles the holder to use the designation % UROPEAN CANCER CENTRE+:
- The certified centres in Germany must first and foremost use the DKG logo (DE). In addition, the ECC logo may be used. Sole use of the ECC logo is not permitted.

#### Centres with a location outside Germany

The certificate issued by DKG likewise entitles the holder to use the designation % UROPEAN CANCER CENTRE (ECC)+ Besides the logo % DKG-certified Organ Cancer/Oncology Centre+, other logos with the designation % UROPEAN CANCER CENTRES+(together with the organ specification) are also available. The logos can be used instead of or in combination with the logo % DKG-certified Organ Cancer Centre/Oncology Centre+.

### International certificates (in preparation)

The centres abroad may request an international certificate that has been designed in line with the international corporate identity (similar to the ECC logo). Various languages are possible. The fee for these certificates is EUR 160 plus the costs for a certified translation.
